The goal is to create deep and lasting solutions by focusing on restitution, reconciliation, restoration, and the collective future. This panel hopes to shed light on religion-based efforts to solve problems in communities through justice circles, alternative punishment, debt forgiveness, prison ministry, and sentencing reforms.
